












Overview

Overview

The main exhibition venue of the 14" WCIF included six pavilions, including the Western Cooperation Pavilion, Electronic Information Pavilion, International Cooperation Pavilion, High and New Technology Pavilion, a quipment Manufacturing Pavilion and Agriculture Industry Pavilion, as well as the outdoor exhibition area. Meanwhile, a number of branch exhibition venues were established in related cities (prefectures) of Sichuan for hardware and mechanical and electrical products, furniture and home furnishing, leather shoes, and traditional Chinese medicine.

03 Analysis report

A total of 1,378 overseas enterprises from 72 countries in five continents attended the 14" WCIF, accounting for 43% of the total number of exhibitors at this fair, with a total exhibition area accounting for 40.2% of the total exhibition area of the fair. Compared with the 13" WCIF, the proportion of exhibition areas of foreign exhibitors in the total exhibition area of the fair increased by 6.9%, while the proportion of foreign enterprise exhibitors increased by 6.8%, and the number of countries concerned increased by 17.












► Chinese exhibitors


Industrial structure of exhibitors

At the 14" WCIF, the furniture and home furnishing industry played a leading role, accounting for 15.6%; the electronic information and high-tech industries saw an increase, ranking the fifth and seventh among all the industries.

The local visitors accounted for 51.76% of the total number of visitors to the 14" WCIF. The rest visitors are from other areas (See the figure below): 60.22% from Southwest China, 5.23% from North China, 7.78% from South China, 3.42% from the Northeast China, 5.97% from Central China, 11.17% from East China, while 6.21% from Northwest China.





Analysis on concluded transactions

This WCIF made the exhibitions and presentations as well as series of activities effective carriers for both Chinese and foreign enterprises to enter the market in the western part of China and make investment in Sichuan. A total of more than 4,000 enterprise exhibitors from 72 countries and regions, 28 Chinese provinces (autonomous regions and municipalities) and Xinjiang Production and Construction Corps attended the fair, and the total volume of transactions reached RMB 107.83 billion. The fair included 56 investment promotion activities, including eight major activities and 48 special activities, about half of which were international activities, covering more than 10 fields, including investment, trade, finance, education, culture, agriculture and tourism; contracts for 462 investment projects were signed, with a total amount of RMB 563.18 billion, including RMB 526.46 billion from 437 domestic investment projects, and USD 5.92 billion from 25 foreign investment projects.

▶ The Opening Ceremony cum. The 6th Western China International Cooperation Forum

The Western China International Cooperation Forum, which is one of the major events at the WCIF, was first held in 2008. After five years' development under great support of related ministries and commissions and governments of other provinces (autonomous regions and municipalities), it has become an important platform in the western part of China for global connections, communication and cooperation for mutual benefits. Meanwhile, it has made great contribution to the overall diplomacy of China and the opening-up of the western part of China. At the 14* WCIF, seven top-ranking acceptance of Greinarch difficient from foreign governments delivered keynote speeches.

► The 6th Western China International Sourcing Fair

The 6" Western China International Sourcing Fair was jointly sponsored by the Ministry of Commerce of China, UNOPS, UNPD and Sichuan Provincial People's Government. A great number of economic and trading activities, including on-site business negotiation, 2013 China Supply Chain Management Summit, UN Procurement Introduction and Matching Fair, and special matching fairs for equipment manufacturing, food and other industries, were held. More than 19,300 professional visitors from 69 countries attended the fair.

► The 8th China-EU Investment and Trade Cooperation Fair

The three fair attracted more than 1,000 visitors and more than 800 Chinese and European enterprises, including more than 180 European enterprises. It focuses on a number of strategic emerging industries, including energy saving and environmental protection, new energy and new materials, modern agriculture, bio-pharmaceuteclas, general aviation, high-end equipment manufacturing and ICT. More than 700 Chinese and European enterprises attended more than 1,100 matching meetings and signed contracts valuing RMB 3.2 billion and intended cooperation agreements valuing RMB 3.2 billion. ▶ The 7th Conference on Investing in Western China cum. Ceremony for Signing Economic Cooperation Contracts

It was jointly sponsored by the National Development and Reform Commission, the people's governments of 12 provinces (autonomous regions and municipality) in the western part of China, and the Xinjiang Production and Construction Corps. Related officials made an introduction to the major industries, investment opportunities, investment environment and relevant policies. Contracts for 332 projects were signed, with a total amount of RMB 444.81 billion, covering a wide range of fields such as electronic information, equipment manufacturing, beverage and food, oil and gas and chemical engineering, energy and power, vanadum, titanium and rare earth, and autor manufacturing.

► The 4th Western China Financial Forum

The forum consists of the main forum and the seminars. The main forum focuses on "the financial industry and the economic development in the western part of China", including a number of keynote speeches. The seminars had discussions about policies and measures for promoting economic and financial development in the western part of China. The themes of these seminars include: "financial support and innovation for new-type urbanization", "financial support for the development strategy featuring multiple growth points and poles", and "ways to construct financial center in the western part of China".

▶ Opening Ceremony of 2013 Asia Education Forum

The Asia Education Forum was jointly sponsored by Boao Forum for Asia, UNESCO and China Scholarship Council, aiming to set up a high-level cooperation and communication platform for Asian education authorities, colleges and universities, experts and scholars, international organizations, enterprises and other parties concerning about education.


▶ Visit of ASEAN delegation of ministers of commerce and trade — Conferences on ASEAN Trade and Investment Policies

Upon the approval of the State Council of China and under the organization of the Ministry of Commerce, the ASEAN delegation of ministers of commerce and trade visited China from October 22 to 26. Then, the Conferences on ASEAN Trade and Investment Policies were held in Chengdu, as one of the achievements of the China-ASEAN Summit, which was held in October.









Sichuan has been following the guideline to establish a "7+3" industrial mode to develop seven competitive industries, including electronic information, equipment manufacturing, energy and power, oil and gas and chemical engineering, vanadium and titanium steel, beverage and food and modern TCM, and three potential industries, including aerospace, auto manufacturing, and bioengineering and new materials. This provides a lot of new opportunities for investment.

In 2013, the local GDP of Sichuan province reached RMB 2.6 trillion, up 10%; three more cities (prefectures) saw total local GDP increase to more than RMB 100 billion, totalling the number of such cities (prefectures) to 12.1 z more counties (county-level cities, districts) saw total local GDP increase to more than RMB 10 billion, totaling the number of such counties (county-level cities, districts) to 97; the industrial added value of industrial enterprises above designated size had an increase of 11.1%; main operating income of the seven competitive industries mentioned above had an increase of about 16%; output value of new and high tech industry reached RMB 18.1 to billion, up 18.2%, solar revenue of flourism industry reached RMB 183.7 to billion, up 18.2%, solar revenue of flourism industry reached RMB 183.7 to billion, up 18.2%.









Sichuan has abundant resources, a good economic development and large population. Therefore, it has obvious industrial, market and location advantages for laying a solid foundation for the development of the convention and exhibition industry. As the capital of Sichuan province, Chengdu has been honored 'the land of abundance'. As the biggest trade center in the western part of China, it has a large trade market with great influence on 287 million population in 12 provinces (autonomous regions and municipality) in the western part of China.





In 2000, China put the Western Development strategy into full implementation. Since then, a number of preferential policies have been made to attract capitals, technologies and human resources to the western part of China, which therefore has become a hot land for investment. The Chengdu-Chongqing Economic Zone, established upon approval obtained in 2011, has become the "fourth economic growth pole" of China, following the Pearl River Delta, Yangtze River Delta and the Bohai Rim. In recent years, the government of Chengdu has provided great support and value provided great support and value provided great support and value of convention and exhibition industry, making great efforts to establish a regional convention and exhibition center.





In addition to the seven competitive industries (including electronic information, equipment manufacturing, energy and power, oil and gas and chemical engineering, variadium and titanium steel, beverage and food and modern TCM) and three potential industries (including aerospace, auto manufacturing, and bioengineering and new materials). Sichuan will also focus on the development of six strategic emerging industries, including new-generation information technology, new energy, high-end equipment, new materials, biological technology and energy saving and environmental protection.

The development of industrial economy is especially important. Therefore, great efforts should be made to: accelerate improvement of comprehensive supporting systems for electronic information, equipment manufacturing and auto manufacturing industries; incubate strategic emerging industries and characteristic and competitive industries; lead with surpluss capacity of the steel, cement, electrolytic aluminium and plate glass industries, and promote restructuring of steel, cement and coal industries; lead white spirit industry to make restructuring and transformation based on market; promote the implementation of "smart manufacturing program" and "integration of three networks" (including radio and TV television network, telecommunication network and Internet); accelerate construction of "fivoadband in Sichuran" and develop Schulan into "a Chinese City Well-Known for Software", develop "big data", cloud computing, Internet of thinss, Information security and other emergina insulations.

The development of service industry should be accelerated. Emphasis should be laid on: development of producer services, including modern financial services, modern logistics services. R&D and design services and information services; development of life services concerning health, elderly care and culture; acceleration of development of e-commerce, service outsourcing and other emerging service industries. The development of service industry should highlight ecological and cultural characteristics and promote deep integration of culture and tourism.
